## **Admission Arrangements for Year 6 to Year 7 Transfer**

Eden Boys' School is part of Star Academies. As an 11-18 progressive and inclusive Muslim faith school, the Governing Body will consider all applications equally without reference to faith.

### **General information**

Before applying for admission, parents are advised to find out more information about the school and the admission arrangements that will be followed. You can do this by:

- attending the Open Evening at Eden Boys' School;
- visiting our website at [www.edenboyspreston.com](http://www.edenboyspreston.com)
- reading the Lancashire County Council Council's (LCC) 'Secondary School' composite prospectus.

### **Application procedure**

1. You must complete your home Local Authority's common application form by 31<sup>st</sup> October. If you are resident in the area administered by LCC, then you can either apply on-line at [www.lancashire.gov.uk/schools](http://www.lancashire.gov.uk/schools) or complete the paper form, which is available from [www.lancashire.gov.uk](http://www.lancashire.gov.uk). If you apply on-line, then there is no need to complete a paper application form.
2. Unless there are exceptional reasons for the late completion and submission of the common application form, late applications will not be considered at the same time as applications received by the closing date.
3. You are allowed to name three (3) different schools on the application form in preference order. You are advised not to name the same school more than once or to only name one (1) school, as by doing so, you may limit the chances of gaining admission into one of your preferred schools.
4. If you want your child to gain admission into Eden Boys' School, then it is important that you put Eden Boys' School as your 1<sup>st</sup> preference school on the application form.

## **Allocation process**

1. The admission process is co-ordinated by LCC in accordance with their secondary co-ordinated admission scheme.
2. After the closing date for receipt of applications, LCC will provide details of all applications received to Eden Boys' School. LCC will not provide Eden Boys' School with details of the rank order of preference of the applications. This is because, by law, all admission authorities must consider all preferences equally.
3. If the school receives fewer applications than the published admission number, then the Governing Body (GB) will advise LCC that all applicants can be offered admission into Eden Boys' School.
4. If the school receives more applications than the published admission number, then the GB are legally required to consider all the applications against the school's published admission policy, which can be found at [www.edenboyspreston.com](http://www.edenboyspreston.com)
5. After applying the admission policy for the school, the GB will produce a list of children who have the highest priority for admission. This list of children who can be offered admission will be sent to LCC. Along with the list of children provided by Eden Boys' School, LCC will have similar information for all the schools in the area and from other Councils.
6. In the initial allocation process, it is possible that children can be offered admission at more than one school. As the law requires that no children must be offered admission at more than one preferred school, LCC acting on behalf of all schools will ensure that the single offer of a school place is made at the highest ranked preferred school on the application form. For example, if a school place can be offered at the 1<sup>st</sup> and 2<sup>nd</sup> preference school, a place will be offered at the 1<sup>st</sup> preference school.
7. In the event that your child can be offered admission at more than one preferred school and In order to avoid missing out on gaining admission into Eden Boys' School, you are advised to consider putting Eden Boys' School as your 1<sup>st</sup> preference school on the application form.

## **Offer of a place**

1. When the allocation process is finally complete, LCC will ensure that on – line applicants will be sent an email on or as soon as possible after 1<sup>st</sup> March informing you of the school at which a place will be offered. Offer letters will be posted out if you applied using a paper application.
2. If a place is offered at Eden Boys' School, it is important that you advise the school, if you no longer require the place offered. This will allow LCC, on behalf of Eden Boys' School, to offer the place to a child who could not initially be offered admission.
3. As Eden Boys' School can only offer admission up to the published admission number, unfortunately, not all children will be offered admission. The letter from LCC will provide the reasons why a place could not be offered and the details of the alternative school offered.

4. Parents of children refused admission for Eden Boys' School's year 7 group each September, can request LCC to include their child's details on the waiting list for Eden Boys' School. The school maintains the waiting list, in accordance with the school's oversubscription criteria until 31<sup>st</sup> December in the academic year of Year 7 admission. Parents' are advised to contact the school, if they want their child's details to be kept on the waiting list, from the spring term onwards
  
5. The LCC decision letter will advise you of your right of appeal to an independent appeal panel against the decision of the GB of Eden Boys' School not to offer your child admission.
